### Bert's Story



Bert Wasierski, Renville County Veteran Service Officer

Roberta, "Bert" Wasierski began her twenty year military career in the U.S. Army in 1970. During her first ten years, she played the flute, piccolo and sang in the Women's Army Corps Band at Ft McClellan, Alabama, 33<sup>rd</sup> Army Band in Heidelberg, Germany, 79<sup>th</sup> Army Band in the Panama Canal Zone and the 4<sup>th</sup> Infantry Band at Ft Carson, Colorado. She then served as an Army Recruiter, Training NCO & First Sergeant for the Army Recruiting Command in Minnesota, Wisconsin and Ft Sheridan, Illinois for the next ten years. On June 17, 1990 before her official retirement from the army, Bert began the next chapter of her career as the Renville County Veteran's Service Officer (VSO). Bert and her current staff, Karen Davis, Veteran Technician, Harry Hawkinson, Assistant Veteran Technician, and Ron Kopacek, Veteran's Van Driver, have seen many changes over the past 21 years including

programs offered for Veterans and active duty soldiers, office location, and the use of technology. When Bert started working for the county, the Veterans Service Office was located with the Public Health Department on the west edge of Olivia in a building the county rented from Elmer Zenk. Bert and Karen remember that the floors were cold and the space was limited. Later that year, the County Board decided to build the County Government Services Center and there would be office space for the Veteran's Service Office department in the new building. At the time the floor plans were drawn up, Jim Tersteeg, the County Auditor/Administrator asked Bert to design the office space for the Veteran's Service Office. The Veteran's Service department moved into their new space on President's day weekend in 1992.

The office did not have a computer in 1990, so Bert wrote notes while gathering information from the veterans, soldiers and family members and then Karen typed the information using carbon to make copies. Bert applied for a technology grant, and in 1995 the office received the department's first computer. Bert and Karen taught themselves how to use the new computer.

When Bert became the VSO, the staff began to focus on outreach to local veterans and their families. To connect with them, posters were put up, and Bert did local radio spots on the Ruby Blum show broadcast on KOLV. The office did outreach to the local national guardsmen unit which had not be done before. The federal government was considering the reduction of veteran's benefits, so Bert organized local

veterans and traveled with two chartered buses full of veterans to join a protest at the V.A.

Hospital in Minneapolis. Now Bert communicates through Facebook to send messages and live chat with local soldiers who are deployed in Iraq and Afghanistan. Upon urging from her son and daughter, she learned to use Facebook. Bert

also uses Facebook to inform veterans and community members of upcoming events.

In 1990, Operation Desert Storm was the first deployment that Bert worked with as the Renville County VSO. A large number of troops from Renville County were part of this deployment. Bert quickly took action back at home and pulled together parents and families to support the soldiers. The next major deployment of our Renville County National Guard unit for Iraqi Freedom occurred on September 1, 2004, with the troops returning on December 14, 2005. Bert flew to Fort Dix, New Jersey to meet the troops when they returned with claims along representative, James Kelly. The two were the first to meet the troops when they returned home after deployment. It was the beginning of the Yellow

Ribbon program which was designed to help returning soldiers and their families with claims processing, benefits access, and reintegration. This past year she went to Ft Lewis, Washington to meet the 34<sup>th</sup> Infantry National Guard of MN and to Ft McCoy to meet the local Soldiers of the 1-151 Field Artillery when they returned from a deployment to Iraq.

Bert worked with local legion posts to have a Renville County Veteran's Memorial built and installed on the courthouse lawn. The county's legion posts raised the funds to pay for the memorial. The memorial was dedicated at a special ceremony on November 11, 1996. The head of the Veterans Administration Regional Office, Ron Henke, was present for the dedication along with color guards from the county's Legion Posts. Attendees then traveled to the Fairfax Legion for a dinner and evening of Karaoke.

Bert has traveled with veterans and their families throughout the past 21 years to several events.

Through BOLD community education, two buses of veterans and their spouses went to Branson, Missouri during the veteran's holiday in November of 1996. On the trip to Branson, the group stopped for a night in Clinton, Missouri and was treated by the local VFW and Legion to dinner and a Dixie land band. Bert arranged to take World War II (WW II) veterans to the dedication of the WW II memorial in St Paul on June 9, 2007. As a part of the dedication, Bert ensured that the Renville County WW II veteran's received their WWII dedication medallions together as a group. Food was available at part of

the dedication including a spam mobile – the veterans enjoyed having spam sandwiches. Bert remembered, "It was a beautiful state program and a beautiful memorial to our veterans." The memorial is an open room within the Capitol Mall located just north of the Veterans Services Building. The designers of the memorial wanted to bring the voices of Minnesota Veterans to the heart of the State Capitol by expressing their journey through the Second World War. A visitor to the memorial cannot help but experience World War II's history, tragedies and social repercussions.

The Renville County Veterans Service office has been involved in sending packages to the local deployed soldiers that first started when Desert Storm was declared in August of 1990. A war that was officially declared one day after Bert's retirement from the Army. Currently, packages are prepared and mailed to 15 local deployed soldiers. VSO staff is gearing up to send packages to the local Red Bull soldiers, who will be deployed in

May, 2011. Contact the VSO office by calling 320-523-3763 if you have a family member who is deployed or will be deployed so they can receive the packages.

Bert will be retiring as the county's VSO later this year, but her latest grant writing efforts have paid off to the tune of \$12,000. The funds will be used to send the next VSO to national training to become certified, for advertising, posting, and stationary, and to hold a county wide Veteran's seminar sometime within the next year.

Bert described her role as one of "building relationships" and says helping veterans is the best job in the world. If she has trouble with a veteran's claim she just keeps working on it until she gets it through the system. Bert loves her job and commented, "Where else do you get to go to work every day with your best friends." Bert's future plans include remaining in Olivia, volunteering, finding time to golf, and spending time with her family. As Bert described it best, "the military blood runs deep in my family." Bert's son, David Wasierski, Staff Sergeant, was deployed to Afghanistan last year and is currently stationed in Fort Lewis, Washington as an Airborne Ranger Sniper. David will be reporting this July to Fort Benning, Georgia as a Ranger instructor. David is married to Nicole Diekman and she is the assistant manager of the Fort Lewis Fisher House. The Fisher House is similar to a Ronald McDonald house, it is a place for military families to stay when their loved ones are hospitalized for illness, disease or injury. Nicole also


was very instrumental in the Family Readiness Group for the 2-5 Infantry Unit while they were deployed to Afghanistan from Ft Lewis. Bert's daughter Amanda Tepfer is working at the V.A. Regional Benefits Office located in the Henry Whipple Federal Building at Ft Snelling and working with Veterans appeals. Amanda was one of the leaders of the Family Support Group for the local 1-151 Field Artillery during their last deployment. Amanda is married to Andy Tepfer, who has served in the National Guard and has had two deployments to Iraq with the local National Guard Unit. Andy is currently training to become a Warrant Officer in the MN National Guard, Andy works with disabled veterans at the Henry Whipple building at Fort Snelling. Bert reflected that she enjoyed her first 20 years in the army, but the last 21 years here at Renville County were even better. She said, "Veterans inspire me, they teach us a lesson in life, each one has a unique story, and it is an honor to go home at the end of the day and know that you were able to help a Veteran!"

# Highway 212 Resurfacing Project to Begin Along with Detours

The Minnesota Department of Transportation will be starting a 28.3 mile Highway 212 resurfacing road project this May. The project will begin on Highway 212 near Renville County Road 16 west of Hector and will run to the start of the 4-lane west of Glencoe. The project will be detoured in three stages and will consist of pavement resurfacing, the addition of turn lane construction and culvert lines. Stage 1 will commence about May 16 through July 1.

Traffic will be detoured on Renville County Road 16, Renville County Road 11, McLeod County Road 18 and State Highway 15. Stage 2 is planned to begin on July 1 and will go through September 2. Traffic will be detoured on State Highway 4, Renville County Road 11, McLeod County Road 16 and State Highway 15. Stage 3 is planned to begin on September 2 and will go through November 1. Traffic will be detoured on State Highway 15, McLeod County Road 17, Sibley County Road 15 and State Highway 22. The total cost of the project will be \$16.3 million and is planned to reduce future maintenance costs, improve pavement strength, improve the ride for motorists and provide spot safety improvements by constructing new turn lanes. ## Renville County Commissioners Adopt Social Host Ordinance

After a hearing during their regular board meeting on February 22, 2011 the Renville County Commissioners approved unanimously to adopt a Social Host Ordinance for Renville County. The Renville County Alliance for the Prevention of Alcohol and Drugs Coalition (RAPID) under the leadership of Annie Tepfer, its coordinator, urged the commissioners to consider the ordinance. The coalition membership includes school superintendents, principals, teachers, parents, youth, clergy, healthcare and business professionals, law enforcement, county attorneys, community leaders and the media. The Social Host Ordinance makes it a misdemeanor offense for an

adult to knowingly provide an environment where underage drinking takes place. For a conviction, the county attorney would have to show that the offender should have known that the consumption of alcohol would take place.

During the hearing, testimony in favor of the ordinance was given by local high school students, a mother of five teenagers, the County Sheriff, Scott Hable, and the Olivia Chamber of Commerce director, Nancy Standfuss. The students cited a recent survey of county students that indicated their top sources for alcohol were friends and at parties. The main goal of the ordinance is to discourage adults from allowing teenagers to drink. The ordinance would not prohibit parents from allowing their own children to have an alcoholic beverage in their home, according to County Attorney, David Torgelson. As an example, he said, "It is and would remain legal for a parent to offer a child a glass of wine during a family event or as part of a religious observance."


According to a 2003 report by the National Research Council's Institute of Medicine, underage drinking costs the nation at least \$53 billion a year, mostly because of traffic deaths and violent crime. The social host ordinance should help to reduce the availability of alcohol for local youth and make communities safer. In 2006, not a single host ordinance existed in Minnesota. As of March 1, 2011, 59 cities and 14 counties have adopted a social host ordinance, and more are actively considering it. Cities with Social Host Ordinances have found success in a reduction in the number of underage drinking parties. They found a reduction in the number of 22 or 23 years olds hosting such parties. From a prosecutor's standpoint, enforcement of the ordinance gives them a great tool to help curb underage drinking. A number of communities and counties in the region, among them, the cities of Fairfax, Spicer, New London, Sleepy Eye, New Ulm, Glencoe and Willmar, have adopted their own social ordinances, along with Kandiyohi and Yellow Medicine counties. The county commissioners would like to see communities across the county adopt a uniform ordinance.

# HRA/EDA Invests in Technology Project Bringing Fiber to the Farm

Funds from the Renville County HRA/EDA will provide seed money for an initiative that supporters hope will result in the installation of fiber optic cable in the southeastern part of the county. At its January meeting, the HRA/EDA Board approved up to \$4,000 to assist Renville County to enter into a joint powers board working to install a fiber optic network that would serve all properties in the City of Fairfax and parts of three townships in the southeastern part of Renville County, as well as properties throughout much of Sibley Renville County. County Commissioners voted on February 22nd to become part of the Joint Powers Board, and Sibley County Commissioners approved membership the following day. Membership by the counties is necessary for rural properties to be served by the project, which is

sometimes referred to as "Fiber to the Farm." The first phase of the project will identify potential users of the service.

The system would provide high speed internet, television and telephone service at a speed of 20 megabit-per-second. This is faster than the service available to many metro area residents and is about 800 times faster than most dial-up service.

Broad-based access to high speed internet would allow more residents the ability to go to school on-line or work from home, not to mention its entertainment potential. Features such as video-conferencing and the ability to instantaneously transfer huge quantities of data would be beneficial for existing businesses and would make the area more attractive to firms seeking to expand or relocate.

# Funding New Uses for Existing Buildings

The HRA/EDA's Business Revolving Loan Fund (RLF) made its fourth loan in December, assisting J and R Electric to move into an unoccupied commercial building on Highway 212 in Olivia. The loan brought the total loans made under the program to \$93,000.

RLF is funded by a combination of a \$99,000 grant from the USDA's Rural Development Program and \$100,000 in HRA/EDA funds.

Loans are available for start-up costs and working capital, building and plant renovations, transportation improvements, and other business needs. Loans are subsidiary to private bank financing, which normally makes up the majority of each project. On its first four projects, the program's \$99,000 investment leveraged \$440,000 in private investment into Renville County communities.

The HRA/EDA has also approved a loan of \$35,000 in EDA funds to the Morton EDA for its purchase of a vacant commercial building on the community's primary commercial corner. Plans call for the building to be sold by the Morton EDA to a private business owner for use as a coffee shop and café specializing in healthy food and showcasing local history and culture, as well as local artwork, beadwork and supplies.

<u>Recyclable Metal/Glass/Plastics</u>: Metal food cans, aluminum beverage cans, glass bottles and jars (ALL colors), ALL plastic containers, including lids. Please rinse all listed items.

Non Recyclable Paper: String, twine, cotton balls, paper towels, napkins, cups, coffee filters, tea bags, waxed paper, candy & gum wrappers, cellophane, foil, plastic wrap, carbon paper, wallpaper, bathroom waste paper, photos, slides transparencies

Non Recyclable Metal/Glass/Plastics: Aerosol cans, paint cans, light bulbs, pens, window panes, mirrors, pottery, ceramics, disposable razors, needles, toys, dishes, glasses, medicine containers, plastic cups, silverware, trays, plastic wrap, foam cups, foam packaging, cardboard milk containers



Recycling Drop Off Sites for Rural Residents are located in each community. The drop boxes are available seven days a week, 24 hours a day.

<u>IMPORTANT NOTE</u>: PLEASE <u>FLATTEN ALL CARDBOARD</u>. By breaking down all the cardboard, more people can utilize this drop box and help keep the site clean and from blowing onto neighboring property owners.
